Stability	All	Valid certificate indicating Stability Index e.g. Cat A, ORCi stability etc. SSSN OK for rally boats.
Australia Sailing Special Regs Construction Standards	All	Builder documents – indicating Cat A compliance or equivalent. See ASSR 3.01-3.03.
Rating certificates and other ORWA documentation as required	Race	IRC, etc – add in your TopYacht boat profile
Sea Survival Certificates	All	Minimum number of qualified crew dependent on race/rally category. Recommended 100%. Add into TopYacht entry
First Aid Certificate	All	Minimum one crew member suitably qualified Add into TopYacht entry
Crew List	All	Entered via your TopYacht registration
Team Shore Contact	All	Entered via your TopYacht registration
Declaration of crew experience	All	Requirements dependant on race / rally category Ref NOR
Radio Declaration form	All	Race Boats (ORWA Form) add into TopYacht Entry Rally Boats (FSC Form) add into TopYacht Entry
Radio Licence	All	At least two crew members suitable qualified. VHF Radio Licence (Image) add into TopYacht Entry
Boat Photo	All	Good colour image of your boat for the tracking and promotion add into TopYacht Entry

Disclaimer and acknowledgement of rights form	All	FSC form to be signed (Upload to TopYacht Club Safety Declaration)
Proof of Sat Comms testing	All	Testing arranged with Race Team
Life Raft Certificate	All	Current Life Raft Inspection Certificate in TopYacht
Personal AIS Beacon ID number	All	Where crew have these units (strongly recommended)
Battle Flag		EOI for a flag to collate numbers wanted

Early Departure	Rally	By 15 th April plus \$260 fee
Crew PLB ID	All	As registered with AMSA
Compulsory Briefing	All	4 th May. All crew encouraged to attend but Skipper and Navigator mandatory
Sailing Instructions	All	SI's may detail additional requirements please read!
